OLD TOWN FESTIVAL 2011 – BBQ COOK-OFF RULES

★ *CTBA Sanctioned* ★

1. All meats, chili and beans must be prepared and cooked in a sanitary manner in the designated area of the cook-off.
 2. Chicken, Pork Ribs or Baby Back, and Beef Brisket are the 3 meat categories.
 3. No pre-seasoned, pre-marinated, pre-cooked, pre-boiled meats allowed.
 4. Meat inspection will be from 5:00 pm to 6:00 pm. After inspections, seasoning will be allowed starting at 6:00 pm and NOT 5:58 pm.
 5. No multiple entries per pit unless approved by HEAD JUDGE.
 6. Meats must be cooked with wood or wood substance only. Gas or electricity may be used to start the BBQ fire only.
 7. Open fires in burn down barrels must have a safety barrier and protection from children and visitors.
 8. Entries will be placed in silver foil to be turned in. NO sauce or garnishes will be allowed. Sauce for cooking will be permitted.
 9. Pinto Beans are dry pinto beans only.
 10. Meat and vegetable products can be used to cook beans
 11. NOTHING larger than the bean may be turned in; we are judging beans and juice only.
 12. Any entry with meat or vegetable product larger than the bean WILL BE DISQUALIFIED.
 13. Beans and chili may be cooked using gas or electricity.
 14. The HEAD COOK is responsible for the actions and conduct of the team. Excessive use of alcohol is grounds for disqualification.
 15. The HEAD COOK is responsible for keeping the cooking area clean. All trash needs to be put in trash bags and placed in dumpster or where it can be easily picked up.
 16. Quiet time is from 12:00 Mid-night Friday night to 6:00 am Saturday. During this time NO loud music, loud talking, etc. will be allowed.
 17. Tickets should be signed by cookers for teams benefit in case they get lost. All trays should be kept free of markings and damage. Should a tray become damaged a new tray can be obtained from the HEAD JUDGE.
 18. Final decisions rest with the HEAD JUDGE.
